**NEWS FROM KELLY** 



**Thank you to CUSD Partner Ray Morgan:** For the past three years, CUSD has partnered with the Ray Morgan Company for copy and printer services. As a result of that partnership, CUSD benefits for a percentage of Ray Morgan's statewide sales. Thus far, this partnership has resulted in \$73,872.00. Regional Sales Manager, Mike Drakulic presented a check for Chico Unified School District to Board President Andrea Lerner Thompson on Wednesday, September 19, 2012, at the CUSD Board of Education Meeting.

**CHS Staff Members Save Student Life:** It was the situation every educator hopes never to encounter--a student collapsed while at school and was not responding. Fortunately for this student and his CHS family, two of our outstanding educators were on hand and trained to deal with such situations. CHS teacher Linda Catalano promptly called 911, while Linda Allen, CHS PE teacher, and Linda Johnson, Health Aide, provided CPR to the student until paramedics arrived. The student's situation was grave and he spent time in Intensive Care. However, as a result of the immediate care he received on the scene, the quick response of the paramedics, and excellent care at Enloe, the student has made a full recovery and is now back at school. First, **thank you** to all three Lindas for their prompt action. Second, this situation has been a reminder to us all that you never know when you will be in a situation where you can save a life. As a result of this situation that happened on their campus, CHS is offering all staff the opportunity to participate in a CPR course on campus. Again, thank you Linda, Linda and Linda and to CHS for taking steps to ensure that additional staff members are better equipped to deal with such situations, should they occur on or off campus.

**Superintendent's Award for September:** Congratulations to Julie Phairas, parent and volunteer at Chico Junior High School! Julie was selected by staff at Chico Junior for her dedicated work and ongoing service to the school. She was awarded the Superintendent's Award at the September 19, 2012, CUSD Board of Education Meeting. Thank you Julie!!

**Marsh Junior High Finalist for Model Autism Site:** Congratulations to Marsh Junior High School on being chosen as a finalist for the California School Boards Association (CSBA) Golden Bell Award. The Marsh Autism program, taught by Taryn Blizman, was submitted for this award by Marsh Principal Jay Marchant and Loma Vista Principal Eric Snedeker for

the outstanding work Ms. Blizman has done in integrating autism students into mainstream activities. An on-site validation committee from CSBA will now visit Marsh to see first-hand the excellent work being done. After the site visit, the committee will make its recommendation to CSBA. If confirmed, the school will receive its award at the annual CSBA Conference in San Francisco on Saturday, December 1, 2012. Good luck Marsh and kudos to Ms. Blizman, her students, and all the Marsh staff and students that work closely with her to make this program such a model for our state!

#### **NEWS FROM EDUCATIONAL SERVICES**

**Common Core State Standards:** Beginning Monday, September 24 from 4:00-7:00 p.m. a team of thirty-seven CUSD administrators and teachers will attend a countywide workshop series about supporting the implementation of the common core state standards. Adopted in California in August 2010, the K-12 Common Core State Standards were developed through a state-led effort to establish consistent and clear education standards for English language arts and mathematics. The Common Core State Standards have been formally adopted by about 90% of the states. A CUSD Board of Education workshop on the Common Core was held on September 5.

**Illuminate Data & Assessment System:** Teachers, administrators and support staff are using our new data and assessment system, called Illuminate, to collect and analyze data to inform decisions about instructional practices, placement and to organize instructional resources to support our students. Over 150 teachers are utilizing document cameras to quickly scan student answer sheets and provide students with immediate results. The Illuminate system provides web-based access to student assessment information in one place, whether from state, district, classroom or curriculum-based assessments.

**California High School Exit Exam (CAHSEE):** The next administration of the high school exit exam will be held on **October 2 and 3** for grade 12 students and adults who have not yet passed the exam. Thanks to the 2012 CAHSEE Site Coordinators and assistants who attended annual training on Friday, September 21: Don Williams, Lori Castaldo, Kathy Sinnott, MaryKay Inserra, Rhonda Odlum, Brian Boyer, Dam La Bar, Cindy Engberg, Damon Whittaker, Andy Moll. Please note that the November administration of the CAHSEE takes place on election day; after a thorough review, the State Superintendent of Public Instruction determined that this date was the only viable option for the November administration.

The Chico Unified district pass rate for students taking the test for the first time in grade 10 continues to exceed the county and state passing rate.

**CELDT Testing:** The California English Language Development Test (CELDT) is given each year to students identified as English learners. Schools sites are conducting annual CELDT testing through October. The CELDT has three purposes: (1) to identify students who are limited English proficient; (2) to determine the level of English language proficiency of students who are limited English proficient; and (3) to assess the progress of limited English proficient students in acquiring the skills of listening, reading, speaking, and writing in English. **STAR Test Results:** Individual student results from the spring 2012 STAR tests have been sent to parent/guardians. If you do not receive your student's STAR score report by September 15, please contact Louise Workman at 891-3000 x171. The dates for the STAR Writing Test in grades 4 & 7 will be March 5 and 6, 2013. The STAR multiple-choice testing window will begin on April 15, 2013. **2010–11 Accountability Progress Reporting (APR):** California's integrated accountability system that reports both the state Academic Performance Index (API), and the federal Adequate Yearly Progress (AYP) and Program Improvement (PI). The following reports have been delayed by the state this year and are scheduled to be released in early October:

- \* 2012 Growth Academic Performance Index (API) Reports
- \* 2012 Adequate Yearly Progress (AYP) Reports
- \* 2012–13 Program Improvement (PI) Reports

**CALPADS:** To fully comply with federal accountability requirements, California has enacted a data collection and reporting system, California Longitudinal Pupil Achievement Data System (CALPADS). Collection and reporting of this data is a joint effort between all CUSD schools, Business Services, Educational Services, Human Resources,

Information Technology, and Nutrition Services. The following CALPADS End-of-Year Reports were certified this week.

- EOY 1: Course Completion / Career Technical Education (CTE)
- EOY 3: Discipline Data
- EOY 2: Program Participation / Homeless Student Data Submission.
- EOY 4: CAHSEE Waivers

This was the first year these reports were required by the state. Special thanks to Joe Loomis, Jen McCall and Jennifer Bevers for a great team effort! CALPADS data submission for Fall 1 (12-13 Enrollment Counts, 11-12 Grads and Drops and Immigrant Counts) begins October 3.

#### FACILITIES & PLANNING / MAINTENANCE & OPERATIONS / NUTRITION SERVICES:

Facilities & Planning--Fair View High School Construction Technology Shop: United Building Contractors is currently on the site pouring the concrete building slab. In the next two weeks the wood framing will get started. The Construction Technology Class, guided by their teacher Matt McGuire, will observe the entire building process evolve from design plans to a finished building.

Facilities & Planning--Inspire School of Arts & Sciences on the Chico High Campus: Inspire is a local charter school that is located on the Chico High School campus. Over the summer, two repurposed portable classroom buildings and one portable student restroom were added to the campus. The buildings will house art and digital media/robotics classes. The buildings were completed on September 7, 2012, and the students and staff are settled in nicely.

**Facilities & Planning--Chico High School Lincoln Hall & Fitness Laboratory:** With abatement and demolition of the existing building occurring over the summer, construction of the new Lincoln Hall and Fitness Laboratory is slated to start September 17. Lincoln Hall will be constructed with a combination of concrete tilt-up walls and structural steel. Modern Building Company will be starting off the project with the underground utility installation.

Facilities & Planning--Pleasant Valley High School New Classroom Building: A two-story, twenty-four classroom building is under construction on the Pleasant Valley High School campus. Underground utilities such as water, storm drains, and sewer have been put in place. Trenches have been dug and reinforcing steel is currently being installed for the building footings. Next week fine grading of the new staff parking lot will start.

Maintenance & Operations (M&O): This month M&O will begins their yearly Fire Inspections with Inspector Rick Doane. The purpose of the fire inspections is to ensure that our classrooms and buildings are providing a fire safe environment for staff and students. Rick informed them that over the last ten years, Chico Unified has made vast improvements in fire safety. He has found that most of the flammable materials brought into the schools have been treated with a fire retardant. The district recommends a product called Inspecta-Shield which is available through the warehouse. It is very safe and simple to use. Once the material has been treated, it is recorded on Flame Retardant Treatment Log that has been supplied to each school. This year the fire department is requiring us to have the Treatment Logs on file at the Corp Yard. All logs are to be in electronic format, typed, and include description of the treated item. Example: you cannot say you treated a rug or curtain, it must say the yellow flowered rug or the green curtain with polka dots, or whatever the item is. The log needs to be updated every year, and reviewed each year by the Fire Inspector. Also, the Inspector will need to view the Fire Drill Log. Some of the things he is looking for during room inspections include art work on the walls (not to exceed 20% of the wall space), daisy chained cords, flammable materials, power strips near flammable materials and more. Remember to keep things that burn away from things that get hot. Each site will receive a copy of their Fire Inspection and corrections to be made. Working together with agencies such as Chico Fire Department we are ensuring a safe learning environment for students and staff.

Along with the fire inspections, M &O is doing the annual Williams Inspections. The Williams Settlement requires school districts to conduct annual facility inspections for all schools and report the findings in their School Accountability Report Cards, in full compliance of the Williams Act, SB 550 and AB 607. The main purpose is to make sure that our facilities are clean and safe. We walk the site with a form referred to as a FIT (Facilities Inspection Tool). After the inspection, the information is recorded on an evaluation sheet were the school is rated

for its overall condition. That information is collected and reported on the SARC (School Accountability Report Card).

#### **NEWS FROM HUMAN RESOURCES**

**Negotiations--CSEA, Chapter 110**: The CSEA 110 and District negotiating teams met on September 19 and are scheduled to meet again on September 26. The teams have been working on a successor agreement which in essence means that the entire collective bargaining agreement is open for review. The teams have reached agreement on the vast majority of issues that have been brought forward and hope to resolve the issues that remain before us so that we can complete the successor agreement. Remaining issues include;

- Stipends for staff who assist with the toileting of students
- New Year's Eve day as a holiday when it falls on a weekend
- Special education transportation aides being included in the "Transportation" article
- Reimbursement for medical out of pocket costs or insurance premiums
- The layoff process and return rights given recent case law

**Negotiations--Chico Unified Teachers' Association (CUTA):** CUTA provided the District with a package proposal on July 18. The teams met on September 6. The District provided the CUTA bargaining team with a package proposal in response to the July 18 proposal and a side by side comparison of the two package proposals. It is evident that there are many areas of agreement. The teams spent the bulk of the September 6 session clarifying the issues in the two package proposals. The two teams met again on September 13. This session focused primarily on the issues of caseloads for Speech/Language Specialists, student ratios for school counselors and school nurses. There was also discussion regarding the termination of the existing dental plan which is no longer available after January 1, 2013, and the options available. CUTA asked to cancel the next scheduled meeting (September 27) but keep other dates that we are scheduled to meet. The primary areas of discussion are:

- Student to School Nurse ratio
- Student to School Counselor ratio
- Caseload maximum for Speech/Language Specialists
- CUTA's request to suspend the agreed upon cap for the District's contribution to medical insurance premiums for one year

**Permanent Location for Inspire School of the Arts and Sciences:** At the October 3, 2012, CUSD Board Workshop, CHS principal Jim Hanlon and Inspire principal Eric Nilsson will share how their two schools are working together with both schools located on the same campus. While the CUSD Facilities Department and the School Board investigated a variety of scenarios, the high cost of construction and limited space have resulted in few options for a permanent location for Inspire other than the current location. The Board, in conjunction with CHS and Inspire, will discuss a longer term arrangement that meets the facility needs for students at Chico High and at Inspire. Staff and public participation in this conversation is welcomed.

**CSUC and PVHS Collaborate on CSU Admissions Information:** The CSU, Chico Office of Admissions made presentations in the Center for the Arts to PVHS senior English classes regarding the CSU application process. To ensure students receive the accurate information they need as they begin to apply for colleges, college prepatory junior and senior English classes attended the presentation. The inclusion of 11<sup>th</sup> grade students allowed them to begin to get a clear understanding of what they need to do to be CSU eligible as seniors. Although presented by Chico State staff, the admission information was applicable to all CSU campuses. ### **New USDA Regulations**

With the start of the 2012-13 school year, the Nutrition Department wanted to provide you with some valuable information regarding changes to our nutrition program. With the Healthy Hunger- Free Kids Act of 2010 which has restructured the nutritional levels in every meal we offer, you will notice some great changes in the breakfast and lunch lines these days.

In accordance with the new regulations you will note the following changes to our menus:

reduced amount of fat an overall decrease in breads and grains while increasing the amount of *whole grains* in the bread and grains offered lower sodium reduced caloric intake increase in leafy green vegetables increased red and orange vegetables offered daily

We believe these new considerations along with the changes from last school year of more in-house food preparation, less processed foods, more local products, and a wider variety of entrees served daily provide your student the opportunity for healthy and fun dining.

Each student will be required to take a variety of fresh fruits and vegetables from our garden bar, at least ½ cup every day. This is a change from years past. This is where we can use your help encouraging them to try new foods. At home, ask what they tried that day; at the grocery store ask them to point out fruits and vegetables they see at their school's fruit and vegetable bar; set daily or weekly goals for fruit and vegetable intake.

#### Foods and Beverages on Elementary School Campus

#### CUSD Administrative Regulation 5030 School Wellness Policy

#### School-sponsored Events During the School Day

(such as, but not limited to, classroom celebrations, or food on campus)

By July 1, 2012, parents and teachers will be required to comply with the list of CUSD approved healthy foods for all school related activities, including classroom parties. The district shall require all persons bringing food on campus intended to share with others to adhere to the "CUSD Nutritious Foods Pledge" which must be reviewed and signed prior to bringing food on campus. Class parties or other celebrations shall be held after the lunch period when possible.

By July 1, 2012, the Board shall require school staff to avoid the use of non-nutritious foods as a reward for students' academic performance, accomplishments, or classroom behavior.

#### **Celebrations**

All classroom celebrations must follow **California Health and Safety Codes**.

Additional Regulations-SB 965, SB 12, Education Code Section 49431.5, California Code of Regulations Section 15576 and Cal Code Section 114021 Compliance with Food Laws, Foods shall be obtained from sources that comply with all applicable laws, i.e. prepared by a certified source using proper safety and sanitation practices. Foods prepared in a private home or a non-certified location may not be offered for sale or used in a facility for public consumption. According to the USDA [funding source] this applies to anywhere the reimbursable school meals are sold or eaten, which in California schools means virtually the entire campus.

You are not required to attend staff meetings and training, but we provide these training to provide necessary and required information for the operation of Nutrition Services. You are paid for your attendance, so we strongly encourage you to attend.



You received your menu planning guide this past week. Please get it filled out and post it in your kitchen on your warmer. This will help you with your ordering and it will give your sub vital information for subbing in your kitchen.

Please make sure that you are stapling your daily production sheets together along with your bakery delivery paper. If you have a supper program at your site please staple their paperwork along with yours daily. This is very helpful with making sure we get the paper work filed properly in the office.

#### NURITITION SERVICES-REGULATIONS AND HEALTH GUIDELINES

#### PERSONAL HYGIENE

- .1 Hair shall be properly restrained, including facial hair. Hair shall be pulled back away from the face and restrained in a hair net. A bonnet, hat or hairnet must be worn for short hair. Hair spray is not an adequate restraint. Hairnets, caps and bonnets are available from the Nutrition Services Office. If you would like to purchase different ones than what is provided, you may do so.
- .2 Employees shall wear gloves during meal preparation, serving and handling of food items.
- .3 Employees shall <u>not have artificial nails</u>, nails that are not clean, not trimmed and not smooth or have fingernail polish. Nails shall not be longer than ½ cm in length.
- .4 Gloves shall be changed as often as hand washing is required.

#### PROPER ATTIRE

- .1 Wear clean, washable and neat garments.
- .2 Long pants are recommended, anything else should be below the knees.
- .3 Short or long-sleeved shirts only.
- .4 No tanks tops or sleeveless tops can be worn.
- .5 Wear school issued apron during preparation at school. (Do not wear apron to and from work.)
- .6 Take off apron before using the restroom.
- .7 Wear comfortable, closed toe, leather type, and low-heeled shoes with a skid resistant sole. (Canvas tennis shoes and open toes shoes are not allowed.)

Even though it's HOT.

please don't forget.

.8 Food service employees shall not wear dangling or loose jewelry.

#### KITCHEN RULES

- .1 Please do not ever leave the kitchens unattended, if this situation is unavoidable, please leave the kitchen safe.
- .2 All employees are entitled to a rest period, which, insofar as practicable, shall be in the middle of each work period. The rate of fifteen (15) minutes net rest time per three and one-half (3 ½) consecutive hours worked daily. All employees employed for a work period of more than five (5) hours per day shall be entitled to a duty free meal period of not less than (30) minutes, but all employees employed six (6) hours or greater are required to take a 30 minute lunch period. If you leave campus, remember you are to be back at your workstation within the allotted break time.
- .3 Telephone usage-
  - For emergency only
  - Make your calls during your break or lunchtime and limit them to 5 minutes. This also pertains to incoming calls.
  - Cell phones are only used during break time and turned off during work hours. This includes texting.
- .4 No use of personal electronic devices during work time, such as iPods or mp3 players.
- .5 Only authorized personnel are permitted in the food service area.
- .6 All food must be consumed while on duty/break time and will not leave the campus. Do not eat/drink while serving food.
- .7 By State law, no smoking or tobacco chewing shall occur inside food facility or on district grounds or in district vehicles.
  - Employees will observe rules of common courtesy and food safety, including but not limited to:
    - .8.1 Do not sneeze or cough near foods. If you must, turn your mouth into your shoulder area. Wash hands and change gloves if contaminated.
    - .8.2 Wash hair and bathe daily.
- .9 Follow State and local public health requirements.
