NEWS FROM EDUCATIONAL SERVICES

Elementary Report Cards: On Wednesday, January 23, elementary teacher representatives from each site met to explore the report card option that is available through CUSD's data system, Illuminate. The representatives plan to present the grade-level samples during site staff meetings and gather feedback via surveys. The next meeting is scheduled for February 13, 2013.

Common Core State Standards (CCSS): Common Core training continues. School sites are sharing common core information at faculty meetings. Laura Manning, Maggie Ricketts and Cynthia Zwald attended Common Core Math training on January 16 and 17. The Administrator's CCSS Implementation meeting was held Monday, January 14, from 4:00-7:00 p.m. A team of thirty-eight CUSD administrators and teachers attended the fourth meeting of a countywide workshop series about supporting the implementation of the CCSS.

Adopted in California in August 2010, the K-12 CCSS were developed through a state-led effort to establish consistent and clear education standards for English language arts and mathematics. The CCSS have been formally adopted by about 90% of the states. A CUSD Board of Education workshop on the Common Core was held on September 5.

Adoption of Modifications to the CCSS for Mathematics and Approval of Course Models for Higher Mathematics: The State Board took action to approve recommendations to modify the CCSS standards in mathematics pursuant to direction provided under SB 1200 (Statutes of 2012). The modifications include some revisions (minor) in the lower grades with the primary modification being the rescission of a separate and unique course created for 8th graders taking Algebra I. Instead, one set of CCSS Algebra I standards will be taught regardless of the grade the course is taken. To encourage the ongoing increased placements of 8th graders in Algebra I the new K-12 Mathematics Framework under development, will include a chapter devoted to accelerated pathways for middle grades and high school students. Local districts will determine whether a student is ready for Algebra I in 7th or 8th grade. The new 8th grade CCSS math standards have already been approved for those students not taking Geometry or Algebra I in 8th grade and they are considered very rigorous. The State Board also approved the Model Courses for Higher Mathematics. These model courses include both traditional course sequencing of higher math but also the ability to offer integrated courses that meet all CCSS standards over the course of high school. It will be determined by local districts whether to continue to offer course sequencing, integrated or both.

The following implementation strategies were recommended to the State Board:

- Devote a chapter in the K-12 Mathematics Framework to accelerated middle and high school pathways, course sequencing strategies and diagnostic readiness tools.
- Issue clear communication with the field regarding teaching Algebra I.
- CDE and stakeholder groups should be encouraged to hold webinars and trainings on the changes to CCSS mathematics and accelerated pathways
- Seek state and federal funding for a training of the trainers to assist educators regarding accelerated pathways, course sequencing, delivering instruction in the new 8th grade CCSS math standards, etc.
- Have the State Superintendent and SBE President meet with higher education to ensure integrated math courses will be fully accepted as part of A-G or other entrance criteria in math.

California Longitudinal Pupil Achievement Data System (CALPADS): Thanks to Jen McCall and Joe Loomis for spearheading the collection and refining of CALPADS data resulting in the state certification of the Fall 1 and Fall 2 CALPADS. To fully comply with federal accountability requirements, California has enacted a data collection and reporting system called CALPADS. Collection and reporting of this data is a joint effort between all CUSD schools, Business Services, Educational Services, Human Resources, Information Technology, and Nutrition Services. CALPADS data submission for Fall 1

includes: (12-13 Enrollment Counts, 11-12 Grads and Drops and Immigrant Counts) It began October 3 and went through mid-December.

California Accountability & Improvement System (CAIS): CUSD is participating in a pilot program of the California Department of Education which allows the district to upload and manage district and school plans. Over the coming months, the district plan will be input into the new system. CAIS is an online school and district information management tool which allows districts to manage and monitor implementation of strategies, actions tasks and progress toward goals.

District Assessments: Students in grades 2-6 are currently participating in district student progress assessments in mathematics. Teachers will analyze results to better understand student learning needs and to plan instruction. Students will be assessed one more time to track progress and identify learning needs prior to the state STAR tests in mid-April.

Leadership Team: A Leadership Team meeting was held on January 17 in the Large Conference Room from 3:30-5:00 p.m. Thanks to **Pedro Caldera** and **Dave McKay** who presented on gang prevention action planning and to **Deanna Holen** and **Damon Whittaker** who presented on Common Core implementation strategies. **Jack Danielson** presented the Golden Apple Leadership Award to Vince **Enserro** for the month of January. Congratulations to Vince and Thank you Jack!

District Advisory Council (DAC): The DAC met on **January 24** in the Large Conference Room from 12:30-3:00 p.m. The purpose of the DAC is to provide a forum for open two-way communication between the district and school sites as well as guidance and support for Common Core State Standards implementation.

Physical Education Testing: The state-required PE testing begins February 1.

California High School Exit Exam (CAHSEE): The next administration of the high school exit exam will be held on February 5 and 6, for grade 10 students and for grade 12 students and adults who have not yet passed the exam.

STAR Testing: STAR site coordinators have been identified for this year's STAR testing. Site Coordinator training will take place in February. The dates for the STAR Writing Test in grades 4 & 7 will be **March 5 and 6.** The STAR multiple-choice testing window will begin on **April 15**. The 2012 STAR test results were released approximately August 31 and may be found at: http://star.cde.ca.gov/

SEASONAL INFLUENZA PREVENTION

As educators, we know that students must be healthy in order to do their best in school. With student health under my purview as State Superintendent of Public Instruction, I am keenly aware of how quickly an illness can spread through classrooms and entire schools. With this in mind, the news about the seriousness of the current flu season is of great concern. At the end of December, 41 states had reported widespread cases of influenza. Because the virus is traveling from east to west, flu cases have just begun to appear in California. Therefore, before the flu is widespread in California, please remind staff, students, and families about proper precautions to stay healthy.

The Centers for Disease Control and Prevention (CDC) recommends that everyone aged six months and older receive an annual seasonal flu vaccination. According to an analysis by the National Center for Health Statistics, approximately 38 million school days are lost each year due to seasonal flu. A separate study showed an association between children being sick and parents missing work to care for them. These statistics exemplify why our schools should adhere to the CDC's recommendations and direct parents to their child's health care provider, local health department clinic, or local pharmacy for a seasonal flu vaccination.

Please remember that stopping the flu starts with you. A flu vaccination is the best and most effective way to protect students, school staff, parents, and of course, ourselves.

Cold Weather:



As we all know, this month has been extremely cold. Earlier this month, I sent an email regarding what is called "make-up air". Simply put, Cal OSHA (regulation 62.1) requires a percentage of fresh outside air (15-60 cfm per person) brought into the room through the ventilation system. That applies both winter and summer. They also require that the fans on those systems run continuously during occupied hours. It is very hard to heat 21 degree air, as well as cool down 110 degree air. The inside air is recycled through the system, along with the make-up air. Keeping doors leading to the outside closed as much as possible, is one thing that will help. That includes classrooms, hallways, multi-purpose rooms, gyms, etc. As I sit here typing with my jacket on (yes, I suffer along with you) thank you for your understanding. – *Randy Salado*

The committee will hold an orientation meeting in February to review the Oversight role and bylaws. There are currently two unrepresented groups in the committee makeup, a member of a bonafide Taxpayers Association and a member of a Senior Citizens Organization. We will continue to accept applications from interested individuals to fill these seats. While this committee is charged solely with Oversight, it is the district's intent to include the committee throughout the planning and implementation process to keep them informed on all aspects of Measure E projects from planning to completion.

NEWS FROM BUSINESS SERVICES

Finance Department: The Payroll department would like to remind all CUSD employees that the 2013 payroll tax rates have changed. Everyone's paychecks in 2013 will reflect changes in Federal and State tax rates. The largest change will affect the classified staff for Social Security. The 2% reduction in the employee Social Security tax that we have been enjoying for two years has ended. The employee Social Security tax rate is 6.2% again. Please share this information with your fellow employees.

It is tax time again and the W-2s will be distributed soon. As you prepare your taxes you may decide that you need to complete a new W-4 tax withholding form for your future paychecks. These forms are available in the payroll office.

You may also decide that you want to establish a retirement 403b or 457b account to plan for the future. This process is relatively easy. Meet with your financial advisor, chose a fund that is listed on 403bcompare.com, notify TDS of your election, and let the payroll team set this deduction up for you.

<u>Budget Update</u>: Every January the Governor releases his budget proposal for the coming fiscal year. On January 10 Governor Jerry Brown presented a balanced 2013-14 State budget for the first time in several years. The proposed State budget reflects the fact that the state economy is no longer shrinking and Proposition 30 has taken the pressure off the State to make even larger Budget reductions, hence saving Education and Chico Unified from making devastating budget cuts also. While this budget is optimistic about economic recovery, we need to note that recovery is measured in very small bites. We also need to remember that while we may no longer be losing State dollars we have not yet recovered what we have lost over the past five to six years. The good news in this is for the first time is many years Education will see new dollars without equal reductions. Below is a chart showing CUSD per student funding for past 6 years.

One major component of the budget is a proposed new funding methodology for education called the Local Control Funding Formula or LCFF. The proposed LCFF combines current funding both from Revenue Limits and State categorical resources into a per pupil "Base" with full flexibility and local control. Accountability is also a major component of this funding model reform focusing on the core requirements and outcomes expected of schools and incorporated accountability with the local district budgeting process

More will follow since the actual funding formula has yet to be defined and this is still a proposed concept and will need to either go through the budget approval process or legislative process at the State level. The Governor will next present his May Revise to the January proposal with the hopes of a State budget adoption by June 15.

In the meantime, we continue to work through the 2012-13 school year with the Second Interim Financial report presented at the March 27 Board meeting. Since budgets are a moving and living document, the second interim report will reflect both the updated student attendance projections for 2012-13 as well as the 2013-14 assumptions per the Governors' proposed budget.

Enrollment and Attendance Update: Aside from the State per pupil funding, the other major factor in CUSD revenues is our student enrollment and attendance. As you can see above, the district has been in declining enrollment for several years. Beginning the 2011-12 year our enrollment seemed to have stabilized and in fact grew slightly. Since funding is based on student attendance, any increase in enrollment also increases the student attendance rate. In the fall of 2011 the district implanted a program called Attention2Attendance to help better track absences and truancy so as to improve our rate of students in class every day. I am glad to report that after our first full year of implementation and the filing of our first period attendance report (P1) the ratio of enrolled students to students in class each day improved by .50%. This will affect our funding in 2012-13 as well as future projects. Good job to all our school sites and Jen McCall in the district office for helping make A2A successful. We continue to work

for ways to improve student attendance. Keeping kids is school is our focus! The next attendance reporting period (P2) is in April.

NEWS FROM HUMAN RESOURCES

CUTA Negotiations: The District and CUTA bargaining teams participated in mediation sessions on December 6 and January 11. The teams are scheduled to meet again on February 11. These negotiations are for the 2012-13 school year.

The collective bargaining agreement between CUTA and the District states in part:

"Not later than February 1, the CUTA and the District shall exchange their initial proposals for the next school year(s). The proposals shall be presented to the Governing Board at the next meeting of the Board."

Therefore, the teams will begin negotiations for the 2013-14 school year in the next month.

CSEA Negotiations: The teams recently completed successful negotiations on a three- year successor agreement that resulted in an agreement that was ratified by CSEA 110 and approved by the CUSD Board of Education. The teams will be meeting on January 30 for this purpose.

Staffing for 2013-14: We are in the unenviable position of being an entity that has to determine in February how many staff members we will need in August, before we have a budget or know how many students we will have and what courses they want to take. We will present to the Board at their regular meeting on February 20, a resolution (PKS - Particular Kinds of Service) outlining the services we may not need next year. This resolution will have a list of possible sections/courses that we may not have next year. This list will then drive the process used to determine how many layoff notices will need to be given by March 15 and who will receive them. This is a very labor intensive process and one that is emotionally very difficult. The list that accompanies the resolution will NOT have names but rather will identify the services (i.e., number of categorical positions, number of elementary positions, number and type of secondary positions) that the District anticipates may not be needed next year due to funding and/or enrollment issues. We will be reviewing the seniority list to ensure that it is up-to-date, as that will be an important component to the process.



A quick recap: this school year, USDA put in place the most sweeping changes to our regulations in the 65-year history of the School Meals program. Saturated fat and sodium were decreased; whole grains, fruits, and vegetables were increased; calorie maximums per average meal were established; and many, many other changes, large and small, were put in place. In our district, we've already been doing many of these things for years, but for the first time the new USDA regs

codified what qualifies as good nutrition for our kids. After half a year in real-world operation, we're making a few tweaks. We now have the flexibility to increase the grains and protein we offer, while staying within the same calorie maximums. And don't worry, the new higher amounts of fruits and veggies are still in place, too.


Try lots of different fruits, veggies, and whole grains for a healthy diet. You're bound to find a few you really like!




