


STAR 2012-13 CUSD vs. State Gr. 2-11 CST & CMA




ELA 2012-13 CUSD Schools vs. State Gr. 2-6 CST & CMA




Math 2012-13 CUSD Schools vs. State Gr. 2-6




ELA 2012-13 CUSD Schools vs. State Gr 7-8




ELA 2012-13 CUSD Schools vs. State Gr 9-11 CST & CMA






ELA 2012-13 CUSD Alternative Ed Schools





ELA 12-13 CUSD vs. State by Grade Level CST & CMA




Math 2012-13 CUSD vs. State by Test




Science 2012-13 CUSD vs. State by Grade Level Test






Science 2012-13 CUSD vs. State by End of Course Test CST Only






Change in District API 2012 Base to 2013 Growth




Change in School API - 2013




Schools meeting overall API Targets - 2013




% Elem Schools At or Above 800 API 2013 Growth




% Jr High Schools At or Above 800 API 2013 Growth




% High Schools At or Above 800 API 2013 Growth




