- 8.4 Randy Meeker, Assistant Superintendent Business Services provided the enrollment update. The current year estimated ADA at P-2 is 12, 893. The P-2 ADA at adopted budget equaled 12,876. This creates a very small variance of 17 ADA based on 2<sup>nd</sup> month enrollment figures. The adjusted 2001-02 P-2 ADA was 12.969. The variance between current year P-2 ADA estimate and last year P-2 ADA is a negative (76). The adopted budget accounted for a decline in ADA from the 2001-02 to the 2002-03 years in the amount of (87).
  - The P-2 attendance rate came in at 95.962%. Our estimate was 95.92%. In the 2002-03 fiscal year, we are using a more conservative attendance rate of 95.01% at P-2. This lower attendance rate has a negative impact on what we are projecting for revenue limit dollars. Current enrollment for the  $2^{nd}$  month of 2002/03 stands at 13,640.
