1. EDUCATIONAL SERVICES

1. INFORMATIONAL: Multi-Tiered System of Support (MTSS) Grant Award Update Coordinator Christi Bangsund shared on January 5, 2023, Chico Unified received notification of the California Multi-tiered System of Supports Grant Cohort 3 grant award. Chico Unified applied on behalf of all schools on November 15, 2022 and was awarded the full amount requested - \$1,395,000 over three years. Board President Dalby stated this is informational only, and no action is required.

2. BUSINESS SERVICES

1. INFORMATIONAL: 2023-24 State Budget Update

At 6:46 p.m. Director Charise Bromley came forward to discuss the key highlights of the Governor's 2023-24 budget proposal. More specific details from the Governor's 2023-24 budget proposal will be released in the coming weeks. Additionally, any preliminary trailer bill language will be drafted in early to mid-February. Therefore, an updated multi-year projection (MYP) will be presented at the March Board meeting in conjunction with the 2nd Interim budget presentation to show the impact to Chico Unified's budget. Board President Dalby stated this was informational only, and no action is required.

2. DISCUSSION/ACTION: 2021-22 Independent Financial Audit

At 6:53 p.m. Director Charise Bromley shared an annual independent financial audit is required of all K-12 local educational agencies in California. CUSD had two non-financial audit findings: one finding dealt with internal controls and the other finding dealt with state awards. The district has already addressed the findings noted in the report and made the necessary changes to ensure compliance going forward.

3. DISCUSSION/ACTION: Adoption of Resolution No. 1596-23 Regarding Accounting of Developer Fees for Fiscal Year 2021-22

At 6:56 p.m. Director Charise Bromley stated Government Code Section 66001(a) requires a number of findings be made when "establishing, increasing, or imposing" developer fees. The 2022 Developer Fee Justification Study established the basis for the collection of these fees. In February 2022, the State Allocation Board approved developer fee rates of \$4.79 per square foot for residential development and \$0.78 per square foot for commercial development. On May 04, 2022 The Board of Education for Chico Unified School District approved \$4.49 per square foot for residential development and the State maximum for commercial development. These increased fee amounts were collected beginning on July 04, 2022.
