Committee updates:

- CUSD Bultema informed as Bylaws are finalized for Measure K, an updated set of Bylaws will be amended to Measure E for consistency. The new Bylaws will include Form 700, Conflict of Interest filings.

- Costs reflected within the audit included items such as wireless technology, fixtures, site security (Phase 3 schools to receive during Measure K bond release).
- Some projects came from multiple funding sources.

- Draft Annual Report 2015-16 page 4, General Expenses.
- Proposition 39 and Measure E General Obligation Bonds, Financial and Performance Audit 2015-16 - page 10, Bond Issuance Costs and Measure E Facilities Master Plan.
- CUSD to make corrections and submit final documents to committee. Committee noted Section 8, Conclusions will be omitted on the Annual Report for 2016-17.

Both the Annual Report for 2015-16 and Proposition 39 and Measure E General Obligation Bonds, Financial and Performance Audit for 2015-16 approved. Committee Member Simmons moved to approve, seconded by Vice Chair Francis.
